- 2. Secretary, NDMA / Member, NDMA can co-opt representative from any other Ministry / Department / Organisation concerned with the project as Special Invitee, if and when required.
- 3. The powers and functions of the Project Steering Committee are as under:-
  - Review and monitor implementation of the Project on quarterly basis;
  - ii) Discuss and approve the Organisation-wise / State-wise Annual Work Plan, Annual Procurement Plan and Budget of the Project.
  - iii) Provide administrative clarifications and instructions regarding the project norms and implementation procedures;
  - iv) Review new initiatives and achievements initiated in the project which will have to be brought forward in the Project Steering Committee meetings;
  - v) Review critical findings of Audit Reports;
  - vi) Provide such guidance as it may deem necessary for the project;
  - vii) Discuss and review the status of NCRMP-I and II.
- 4. The Project Steering Committee can however, meet as and when necessary in addition to its quarterly meetings to be decided by the Chairman. The special invitees to the Project Steering Committee will be provided TA/DA as per Government Rules.
