Sir,

l am directed to convey the approval of competent authority to the Phase-I of Centrally Sponsored Scheme (CSS) of National Cyclone Risk Mitigation Project (NCRMP) for Andhra Pradesh & Orissa at a cost of Rs. 1496.71 crore. The scheme will be funded by the World Bank as an Adaptable Programme Loan with an International Development Association (IDA) credit amounting to Rs. 1198.44 crore. The remaining amount of Rs. 298.27 crore will be contributed by the State Governments of Andhra Pradesh & Orissa. The World Bank assistance would be routed through the budget of Ministry of Home Affairs. The scheme will be implemented during the period 2010-11 to 2014-15 by the National Disaster Management Authority (NDMA) in coordination with the Government of Andhra Pradesh & Orissa and the National Institute of Disaster Management (NIDM). New Delhi.

- 2. The project has following four principal components:
- (i) Component A- Last Mile Connectivity
- (ii) Component B- Structural and Non- Structural Measures
- (iii) Component C Technical Assistance for Cyclone Hazard Risk Mitigation.

 Capacity Building and knowledge Creation
- (iv) Component D Project Management and Implementation Support

Component A.C & D will be fully financed by the Central Government through World Bank assistance. The component B will be financed by central and state governments in the ratio of 75:25. The financial details of the scheme are given in Annexure-1. The physical structures to be created under the project are at Annexure-II. The amount to be released will be sent through ECS to the respective states.

3. The Project Management Unit (PMU) at Central level (NDMA) and Project Implementation Unit (PIU) at state level will function for implementation of the project. An online (web enabled) project monitoring and tracking system will be installed and operated by the PMU with the help of the state PIUs and the line departments.

facilitation of the project. Guidelines for financial management and financial reporting of the projects in consonance with the loan agreement will be issued separate in consultation with the Internal Finance Division of Ministry of Home Affairs for compliance. The PMU and PIU shall ensure that the disbursed funds are utilized as pernorms and GFR codal formalities and should not lead to parking of funds. The requisite utilization certificate (UCs) for each activity would be mandatory for subsequent fund release. As per GFR rule 211(1) the accounts of the grantee organization shall be open to inspection by the sanctioning authority and the Internal Audit Wing of MHA whenever it is called upon to do so.

5. The NDMA is directed to execute the project wherever applicable in close coordination with the 'Integrated Coastal Zone Management Project' (ICZMP) of the Ministry of Environment & Forests.
