In continuation of this Ministry's Order of even number dated 24th July, 2015, the sanction of the competent authority is hereby conveyed to re-allocate Rs.35.11 crore for two activities of Component 'C' (Rs. 9.25 crore on account of Shelter level training and Rs.25.86 crore on account of capacity building activities of the States) to States out of allocation of Rs.179.95 crore of Component 'C' under Centrally Sponsored Scheme of National Cyclone Risk Mitigation Project (NCRMP), Phase-II to be managed by Project Management Unit in NDMA as detailed below:


