

MINUTES OF THE REVIEW COMMITTEE MEETING ON END-TERM REPORT SUBMITTED BY M/s AMS FOR THE STUDY "BENEFIT MONITORING & EVALUATION (BME)" UNDER NCRMP (PH. I) HELD ON 15.03.2019 AT 3:00 PM IN OPS. ROOM, NDMA BHAWAN, NDMA, NEW DELHI.

The Review Committee meeting to review End-Term Report for the study "Benefit Monitoring & Evaluation (BME)" under NCRMP (Ph. I) was held on 15th March, 2019 at 3 PM under the Chairmanship of Dr. Pradeep Kumar, Addl. Secretary & Project Director, NDMA, New Delhi. The meeting was attended by the Committee Members from NCRMP Phase II States, Officials from NDMA, and M/s GfK. List of participants is attached as Annexure-I.

2. The meeting started with a welcome note from the Addl. Secretary & Project Director, NDMA. A detailed presentation on the End-Term report for BME Study under NCRMP (Ph. I) was made by the Consultant (GfK) representative. The presentation highlighted specific objectives with key areas of enquiry and qualitative findings of the study.

3. After deliberation involving views/suggestions of participants, following decisions were taken:

- (i) Quantitative and qualitative details of EWDS and cyclone risk mitigation infrastructures (CRMI) under NCRMP I to be incorporated in the report.
- (ii) The concerned SPIUs (AP & Odisha) shall furnish requisite details (qualitative/quantitative) of EWDS and CRMI by 16.03.2019.
- (iii) Quantitative and qualitative findings should be drawn for entire villages and vulnerable communities/population residing upto 10 Km from the coast line, based on the sample size as per the ToR considered for the surveys under the study.
- (iv) The report should have variation profiling for disaster resilience developed at community level due to project interventions during mid-line and end-line surveys under the study.
- (v) Loss and damage assessment should clearly reflect loss of lives/livestock & assets as well as quality of life of vulnerable communities, with and without project interventions.
- (vi) Assessment should be presented State-wise, comparing mid-line and end-line surveys, clearly identifying changes in the income profile of population.
- (vii) Recommendations/Observations and benefits/findings to be summarised and added in the report.
- (viii) The Revised BME End-Term report to be submitted by 18th March, 2019, followed by a discussion on the revised report on 19th March, 2019.

4. The meeting ended with thanks to the Chair and all the participants.
