MINUTES OF 15<sup>th</sup> PROJECT STEERING COMMITTEE (PSC) MEETING OF NATIONAL CYCLONE RISK MITIGATION PROJECT (NCRMP) PHASE-II HELD AT NDMA BHAWAN, NEW DELHI ON 18<sup>th</sup> Sep, 2019.

The 15<sup>th</sup> Project Steering Committee (PSC) meeting of NCRMP (Phase-II) was held on 18<sup>th</sup> Sep, 2019 under the Chairmanship Sh. G. V. V. Sarma, Member Secretary, NDMA. List of officers present in the meeting is enclosed at Annexure-A.

2. A warm welcome was extended by the Chairman to all participants followed by a presentation on status of implementation of project by SPIUs. On the basis of the presentations by the SPIUs and discussions, the decisions arrived at the meeting are as follows:

Agenda I: Award of Early Warning Dissemination System (EWDS) Works:

SPIU	Present status of Tender
Goa	Technical bids opened on 22/08/2019. Three bids have been received. Technical evaluation of bids is under process.
Gujarat	Pre bid meeting held on 06/09/2019 and last date of bid submission is 03/10/2019.
Karnataka	Advertisement for retendering floated on 15 <sup>th</sup> September 2019. Earlier tender cancelled due to system problem with e-tendering portal of Govt. of Karnataka. Last date of Bid submission is 31 <sup>st</sup> Oct, 2019
Kerala	Pre bid meeting held on 17/09/2019 and the last date of bid submission is 10 <sup>th</sup> October, 2019.
Maharashtra	Technical bids opened on 20/08/2019. Two bids have been received. Technical evaluation of bids is under process.
West Bengal	Revised Bid documents is under preparation as per suggestion from the World Bank.

#### Decisions:

- (i) SPIU, Goa to expedite the processing of bids evaluation. TCIL has to finish technical evaluation by 25<sup>th</sup> Sep, 2019 and financial bids to be opened by 6<sup>th</sup> Oct, 2019. Work to be awarded by 11<sup>th</sup> October, 2019.
- (ii) SPIU, Gujarat requested for inclusion of Unified Communication System (UCS) and software for Loacation Based messaging to members of Closed user group (Disaste Management related) in the EWDS tender Document. After detailed discussion this was agreed to, as it will facilitate better dissemination of information to the first responders. SPIU confirmed that there will be minor financial implication (few lakhs only) associated with these additional functionalities under EWDS tender. This will further be integrated with National CAP. EWDS Works to be awarded by 1<sup>st</sup> Nov, 2019.
- (iii) SPIU, Karnataka to award works by 2<sup>nd</sup> week of November, 2019.
- (iv) SPIU, Kerala may give extension of bid submission till 10<sup>th</sup> October, 2019 and issue clarifications to all participants of pre bid meeting by 24/09/2019. TCIL to review LBAS clause in EWDS Tender and submit report by 25<sup>th</sup> Sep, 2019.
- (v) SPIU, Maharashtra to expedite the evaluation process and award the work by 15<sup>th</sup> October, 2019.

(vi) West Bengal: TTL World Bank confirmed that the bid document has been cleared by them and SPIU can go ahead with floating of tender. Accordingly, SPIU will float the tender at once, without further delay. A tripartite meeting with World Bank, SPIU and PMU will be held within a week to resolve the issue of bid security and CRZ clearance.

(i) Progress of Capacity Building Training under Component C – Action Plan for the year 2019-20 and progress so far.

#### A. Goa

#### Decision:

- GSDMA, Gujarat has indicated receipt of Gol Funds asRs 209.86 Cr instead of Rs 262.81 Cr, which was released by PMU till June, 2019. As a result, the unspent balance as on date is indicated Rs 27.80 Crores, instead of 80.75 Crs. It seems releases by Gol during 2019-20 amounting to Rs 52.95 Cr is still held up in Treasury and not passed on to GSDMA. GSDMA to pursue the matter with Finance Department, Government of Gujarat for timely receipt of Funds.

- SPIU Maharashtra to take up matter with AG, Maharashtra to get the Audit Report and share the same with PMU by 30<sup>th</sup> Sep, 2019.

#### Agenda Item VII

#### Miscellaneous Issues:

- (i) There was a discussion on the RCE proposal (Phase-II), pending consideration at the Government/World Bank. The World Bank representative (TTL) informed in this regard that they will be reverting shortly (within 2 weeks) to the DEA with their views. He also observed in this context that there could be likely savings of the order of approximately US\$ 30 million, given that the scope of work (particularly CRMI works) have got curtailed in certain States and besides, there are savings on account of exchange rate variation.
- (ii) In this context the committee (PSC) observed that savings could perhaps be utilised for following additional mitigation activities:
  - a) Coastal Shelter belt Plantation to reduce storm surge effect/action, wind impact etc.
  - b) Lightening arrestors along with structures for withstanding thunderstorm/lightning and/or mounted/fitted lightning arrestors on existing structures in select coastal districts.

The World Bank was requested to facilitate inclusion of above mentioned additional mitigation activities in the pending RCE for NCRMP-II.

- (iii) All the SPIUs to ensure Geotagging of the infrastructure constructed under NCRMP-II and develop the MIS system for the same as already done by SPIU, West Bengal. This will be integrated with the MIS at PMU level.
- 3. The meeting ended with a vote of thanks to the Chair and the participants with a resolve to expedite the pace of expenditure while ensuring close monitoring of quality of works.
