MINUTES OF 18<sup>th</sup> PROJECT STEERING COMMITTEE (PSC) MEETING OF NATIONAL CYCLONE RISK MITIGATION PROJECT (NCRMP) PHASE-II HELD AT NDMA BHAWAN, NEW DELHI ON 18<sup>th</sup> February, 2020 (11 AM).

The 18<sup>th</sup> Project Steering Committee (PSC) meeting of NCRMP (Phase-II) was held at 11 AM on 18<sup>th</sup> February, 2020 under the Chairmanship of Dr. Pradeep Kumar, Special Secretary & Project Director, NDMA. List of officers present in the meeting is enclosed at Annexure-A.

2. A warm welcome was extended by the Chairman to all participants followed by a presentation on status of implementation of project by SPIUs. On the basis of the presentations by the SPIUs and discussions, the decisions arrived at the meeting are as follows:

- MoU to be signed between Revenue Department, SPIU and GIPARD by the end of February, 2020 and the Training to commence thereafter.

#### Decision:

- Capacity Building activities for Government Officials to be implemented as per the training schedule and progress report to be submitted to PMU in the prescribed format on monthly basis.
- SPIU to appoint Social Specialist within a week and confirmed to PMU.

# B. Gujarat

- Identified 60 Master Trainers (MTs) from GSDMA have been provided training by NIDM on all 5 priority sectors (Education, Health, PRI, ULBs, and Rural Development)
- Training at district level will be conducted by MTs from March, 2020.

#### Decision:

 Capacity Building activities for Government Officials to be implemented as per the Action plan and progress report to be submitted to PMU in the prescribed format on monthly basis.

#### C. Karnataka

 09 trainings conducted based on NIDM modules in the five priority sectors covering 03 coastal districts.

#### Decision:

- SPIU to implement training calendar for remaining Capacity Building Training as per schedule and submit progress reports to PMU in the prescribed format on monthly basis.
- Kala Jatha programme planned in 03 districts (Mangalore, Udupi & Karwar) to be completed by March, 2020.

#### D. Kerala

Total 32 trainings conducted in three priority sectors (Health, Education & PRI) covering 6 districts and 888 Officers trained.

- CSMMC to be constituted for all MPCS well before the completion of MPCS and be registered under Society Act and Separate Bank A/C to be maintained with Corpus Fund@ 5 lacs each for all CSMMCs.
- Progress report to be submitted to PMU in the prescribed format on monthly basis.
- Social Management Specialist will be recruited before March 2020.

#### B. Gujarat

- 22 Shelter level CSMMC orientations completed and CSMMC orientation for remaining 73 MPCS will be completed by March, 2020.
- First Aid training conducted covering 125 villages (25 MPCS villages and 100 cluster villages). Remaining 70 villages (including 62 cluster villages) to be covered during January March, 2020.
- Search & Rescue training provided in 11 MPCS villages, covering 20 Talukas with training imparted to 220 people.
- 35 CSMMCs constituted and Bank A/C opened for 26 completed MPCS.
- Corpus Fund@ 5 lacs each released to CSMMCs for 22 MPCS and the Corpus fund will be released for remaining 04 MPCS by January, 2020.

#### Decision:

- Corpus Fund@ 5 lacs each to be transferred to all CSMMCs at the earliest.
- GSDMA to implement training calendar for Shelter Level Training as per schedule and submit progress reports to PMU in the prescribed format on monthly basis.

# C. Karnataka

- CSMMCs are constituted and registered for all 11 MPCS; and separate Bank A/C opened shelter-wise.
- Corpus Fund@5 lacs each approved by Govt. but yet to be transferred to the CSMMCs.

- SPIU to implement training calendar for Shelter Level Training as per schedule and submit progress reports to PMU in the prescribed format on monthly basis.
- · MIS personnel to be recruited by SPIU, Kerala.

#### E. Maharashtra

- MPCS works are yet to be awarded. CSMMC are yet to be constituted.
- · Bye-Laws prepared.
- Government Resolution issued for formation of Cyclone Shelter Maintenance and Management Committee (CSMMC)
