Proceedings of the Project Steering Committee meeting of National Cyclone Risk Mitigation Project (NCRMP) held on 9.11.2012.

The first meeting of the Project Steering Committee after its reconstitution as notified vide OM No. 1/MIT/NCRMP/NDMA/2007-PMU(9)(Vol.-II) dated 31.8.2012 was held under the Chairmanship of Shri P.D. DharChakaravarti, Secretary NDMA on 9.11.2012. The following were present.

The meeting started with a welcome address by the Project Director, (NCRMP) NDMA who welcomed Secretary, NDMA and all other officers present in the meeting. Secretary, NDMA in his address wanted that in future the agenda items be given in details indicating as to what is expected from the Project Steering Committee. Thereafter this being the first such meeting Project Director, (NCRMP) NDMA made a presentation on the project depicting the objectives, the components and the physical and financial outlay of the project. After a brief discussion it was decided that the States must strict to the physical and financial targets indicated in the sanction order of the project issued by Ministry of Home Affairs vide No. 47-1/2010 – DM –III dated 27.01.2011 EFC as conveyed to them vide Ministry of Home letter No. 47-1/2010- DM – III dated 28.01.2011.The deviation if any must be explained in the remarks column, on a Performa being communicated to the states devised by PMU at NDMA to have a record of all these.

The agenda items were then taken up.

1. Position of award of Contracts for various works under Component B for year one and two up to 30.09.2012: The year wise award position of works for both the states was presented in the meeting which is tabulated below.

After the presentation Secretary, NDMA quarried Project Director (NCRMP) Govt. of A.P to explain the reasons for not awarding the year 1 Packages/Works by 30.09.2012 and by when these would be awarded. Project Director (NCRMP) Govt. of A.P. explained that the 33 packages of year 1 could not be awarded due to high rates quoted by the contractors. He explained that on retendering now tenders have been received for 21 packages and they are working on the rest 12 packages also. He also

indicated that now all the packages for year 2 have been tendered and they have fixed 20.12.2012 as the last date for receiving the tenders. He elaborated that all the works would be awarded by February, 2013.

It was found that in case of OSDMA although 80 % of the year 1 works have been awarded but the progress of execution of works is slow with the expenditure of the awarded works only 19 % till 30.9.2012. On being asked about award position MD OSDMA cum PD (NCRMP) Odisha explained that they are working and the remaining works of year one would be awarded by 31.12.2012 and of the year 2 by 31.03.2013.

After detailed deliberations it was decided that

- All the year 1 works needs to be awarded by 31.12.2012.
- All the year 2 works and if year 1 works still remain need to be awarded by 31.3.2013.
- The un awarded works as on 01.04.2013 would be withdrawn from the project along with financial outlay involved.

Secretary NDMA requested both the states to make use of this extended date and ensure that all the packages/works are awarded by this deadline so that works are executed before the project closing date.

(Action: PD (NCRMP) Govt. of A.P. and Odisha).

2. Physical and Financial Achievements of Component B works of year one and two upto 30.9.2012:

a) Andhra Pradesh: It was indicated by PD (NCRMP) Govt. of A.P. in the meeting (the report sent indicated nil up to 30.09.12) that only one MPCS has been completed. In addition 29 roads and one bridge havealso been completed as tabulated below.

b) OSDMA: The progress of completion of already awarded works as tabulated below was found to be even slower than A.P. as only 3 roads have been completed since the start of the project by 30.09.2012. The position is tabulated as under.

Secretary NDMA pointed out that the progress in this respect is also very slow. He emphasized that states must take appropriate steps and speed up the completion of awarded works as per time schedule indicated in the contract document. TTL of the World Bank at that time pointed out that OSDMA must take action against the contractors who have/do not complete the works awarded as per schedulein the contract document to bring discipline in the implementation of these works. Contrarily if there are reasons then these works be regularized by giving them extension in time as per contract agreement.

It was decided that all the hindrances involved may be discussed in the monthly meetings being taken by Principal Secretaries for their solutions, so that execution of works in both the states should move fast.

(Action: PD (NCRMP) Govt. of A.P. and Odisha).

3. Position of Implementation Status of Component A: Early Warning Dissemination System: PD (NCRMP) NDMA explained that since the receipt of NOC of the EOI on 25.07.2012 from the World Bank further action is being taken in short listing the firms/consultants for the selection of partnersagency under this component. He indicated that work for this is proposed to be awarded by 15.01.2013. He explained that the process of award of works has been delayed because previously the agreed World Bank procurement procedure was not being followed. The World Bank representatives desired that that this target date must be adhered to as it has already been delayed.

(Action: PD (NCRMP) NDMA).

4. Status of Award of Contracts under Component C:

a) Consulting Services for Cyclone Hazard, Vulnerability and Risk Assessment for 13 Coastal states/UTs – The process and methodology being followed for the award of this consultancy was explained by PD (NCRMP) NDMA and he indicated that the targeted date for award of this work has like component A has been fixed for 15.01.2013. It was decided that this date must be adhered to.

(Action: PD (NCRMP) NDMA).

b) Preparation of long-term training and capacity building Strategy: It was indicated that this study has already been awarded to SEEDS Ltd and it is being undertaken under the supervision of NIDM. ED NIDM who was not present was requested to immediately convene the meeting of the monitoring committee of this study headed by Secretary NIDM.

(Action: ED NIDM).

c) Damage and Loss Assessment: It was indicated that those firms/consultants who had applied for this study were found of not having experience of undertaking such study. Hence it has been decided by NIDM in consultation with the World Bank to go for rebid. It was decided that this work will be awarded by 15.01.2013 positively.

(Action: ED NIDM).

5. Financial Management: The status of budget allotment and its utilization up to 30.09.2012 is tabulated as under:

The utilization of budget in the first six months for the financial year 2012-13 was found to be only about 26% by the Govt. of A.P. and about 21% by OSDMA. This was found to be quiet low.

It was decided that both the states would speed up the implementation of the works and spend the budget in a phased manner instead of spending it in the last months of the financial year. It was also indicated that the second installment of the budget would only be considered if the states following Financial Management Manual spends the required amount by February, 2013 and sends the utilization certificate in this respect by first week of March, 2013.

(Action: PD (NCRMP) Govt. of A.P. and Odisha).

6. Position of Implementation of Works on Saline Embankments: PD (NCRMP) NDMA in the presentation depicted the implementation status of the works of saline embankments which has not yet been taken up by both the states.

PD (NCRMP) Govt. of AP explained that they had not been able to get administrative approval of 2 saline embankments in view of the steep increase in the administrative cost – Rs 142.05 crores vis-à-vis cost of Rs 94.65 crores indicated in the project appraisal document. He explained that they are working on meeting this increased cost through savings from other components.

MD OSDMA cum PD (NCRMP) Odisha explained that they have taken all the statuary and other clearances and approval of the design and model bid document along with model DPR is pending with the World Bank for concurrence and NOC. After the receipt this work would be tendered and awarded.

It was decided that both the state Govts. Will take up all the issues involved in a time bound manner and move towards awarding the works before the stipulated date of 31.03.2013.

(Action: PD (NCRMP) Govt. of A.P. and Odisha).

7. Position of Environmental clearances of various works as on 30.09.2012: After a presentation on the status of environmental clearance PD (NCRMP) Govt. of A.P. indicated that they have taken the environmental clearance of various works under

component B except for 5 MPCSs, 13 roads and 2 saline embankments. He also explained that since this is a time consuming work these 5 MPCSs and 13 roads have been deleted from the project. However, they are working on getting environmental clearance of 2 saline embankments. On this TTL of the Project with the World Bank indicated that the state Govt. must see that with this deletion some of the villages which were part of the project may not be deprived of the facility of protection under MPCSs and communication of transportation during cyclones through the roads.

MD OSDMA indicated that they have taken all the environmental clearances except for one cyclone shelter for fishing community pending with MOEF GOI. He further added that this case is being followed up and they are expecting its early clearance.

It was decided that both the states would get these clearances in such a way that they works are awarded before the stipulated date of 31.03.2013.

(Action: PD (NCRMP) Govt. of A.P. and Odisha).

9. Budget: The requirement of budget for 2012-13 and 2013-14 was discussed. All indicated that the budget provided during this financial year is sufficient. Secretary NDMA informed that a budget of Rs 250 crores is earmarked for 2013-14 and PMU and PIUs must make plans accordingly for this amount for the next financial year. It was also explained that budget for this financial year (2012-13) may be taken as the unspent budget carried forward from the last financial year and that allotted during this year. This PMU/PIU wise comes to as under.

Finalize TOR for vulnerability study and issue EOI:** The TOR has already been finalized after the approval of competent authority, EOI issued and PMU NDMA is working in short listing of consultants for issue of RFP. The issue already stands discussed and explained in point 4 a of the proceedings.
- **10.4. Complete all contracts by Mid-term Review:** This issue also stand decided as indicated in point 2 of the proceedings that
- All the year 1 works needs to be awarded by 31.12.2012.
- All the year 2 works and if year 1 works remain need to be awarded by 31.3.2013.
- The un awarded work will be withdrawn from the project along with financial outlay involved.

It was decided to scrupulously follow this.

- **10.5.** Completely overhaul the existing or prepare a new MIS: It was decided that this issue will be taken separately in a meeting by Secretary NDMA with NIC and the World Bank.
- **10.6. Prepare and submit IUFRs and claim reimbursements:** It was explained that reimbursement claims up to 30.09.2012 have been filled with the World Bank. Claims up to 30.06.2012 have been cleared by World bank, and those up to 31.03.2012 have actually been reimbursed.
- **10.7.** Opening of separate Bank account by PMU and other agreed financial management arrangements: It was decided that this issue will be taken separately in a meeting by Secretary NDMA with NIC and the World Bank.
