## MINUTES OF 11<sup>th</sup> PROJECT STEERING COMMITTEE (PSC) MEETING OF 'ATIONAL CYCLONE RISK MITIGATION PROJECT (NCRMP) PHASE-II HELD AT NDMA BHAWAN, NEW DELHI on 30<sup>th</sup> January, 2019 (3.00 PM)

The 11<sup>th</sup> Project Steering Committee (PSC) meeting of NCRMP (Phase-II) was held on 30<sup>th</sup> January, 2019 under the Chairmanship of Dr. Pradeep Kumar, AS & PD and Secretary In-charge, NDMA. List of officers present in the meeting is enclosed at Annexure-A.

2. A warm welcome was extended by the Secretary In-charge to all participants followed by a presentation on status of implementation of project by SPIUs.

## Agenda I: Bidding out of Early Warning Dissemination System (EWDS) Works:

(a) Knowledge Partner M/s TCIL (for Goa, Karnataka, Kerala and Maharashtra), M/s PWC (for West Bengal) and Gujarat State Disaster Management Authority (GSDMA) made presentation. Status and timelines of EWDS Works are as under:

(b) On the basis of the discussions, the decisions arrived at the meeting are as follows:

#### Decisions:

- (i) Goa: RFP submitted by SPIU Goa to World Bank on 29.01.2019 for review. SPIU to obtain requisite clearances including CRZ clearance before initiation of tender.
- (ii) Gujarat: Revised RFP was sent to World Bank on 29.01.2019 by SPIU Gujarat. GSDMA shall share the same with PMU (NCRMP)
- (iii) Karnataka: TCIL shall submit revised RfP to SPIU Karnataka by 06.02.2019. SPIU to submit it to the World Bank by within 2-3 days after review.
- (iv) Kerala: SPIU Kerala to submit finalised RfP Document by 01.02.2019.
- (v) Maharashtra: RfP document to be finalised by SPIU Maharashtra by 31.01.2019.

(vi) West Bengal: PWC to submit revised tender document including compliance note on technical DPR by 04.02.2019 to SPIU, West Bengal and tender to be floated by 07.02.2019.

All the States are directed to take necessary clearances from concerned departments/agencies with regard to EWDS and all the clearances to be included in RfP Document. All the States have to award the EWDS works before 31 March 2019.

- (iv) All SPIUs to depute a nodal officer for Web-CRA and the data required for the ongoing development of Web-DCRA by 09.02.2019 and intimate the same to PMU, NCRMP, NDMA for sharing the same with M/s RMSI and M/s AMS for Benefit Monitoring Study for NCRMP-II.
- (v) All the SPIUs to ensure geo-tagging of infrastructure developed under NCRMP, Phase-II.
- (vi) All SPIUs to submit TPQA Report of CRMI works regularly.
- (vii) All SPIUs to update their works on MIS regularly.
