

PROCEEDINGS/MINUTES OF THE MEETING ON DRAFT ENVIRONMENT AND SOCIAL MANAGEMENT FRAMEWORK [ESMF] OF NATIONAL SEISMIC RISK MITIGATION PROGRAMME (NSRMP) HELD ON 03.06.2020 AT 11 AM THROUGH VIDEO CONFERENCING.

A meeting was held through video conferencing on 03rd June, 2020 at 11 AM under the Chairmanship of Dr. Pradeep Kumar, Spl. Secretary & Project Director, NDMA to discuss Draft Environmental and Social Management Framework (ESMF) of National Seismic Risk Mitigation Programme (NSRMP). The meeting was attended by Officials from NDMA, the World Bank and the Consultant (M/s DDF-AKDN JV). List of participants is attached at **Annexure-I**.

2. The meeting started with a welcome note from the Spl. Secretary & Project Director, NDMA. A presentation on Draft ESMF report was made by Consultant's Team. A detailed discussion was held on different chapters of Draft ESMF report. Lots of content of the ESMF report were found very generic and hence, the report needs further revision.

3. After deliberation involving views/ suggestions of participants, the following action plan/way forward was agreed to:

- (i) ESMF should be developed as a simple, field and user-friendly operation document.
- (ii) ESMF should be structured and developed to act as a guide to preparation of design and DPRs.
- (iii) Special Package projects will not be considered.
- (iv) Issues related to temporary relocation, and its implementation plan should be detailed out.
- (v) Livelihood disturbances should be taken into account in implementation planning and to be presented in the form of entitlement matrix.
- (vi) There should be a specific section in the report discussing:
 - (a) Labour Management Plan.
 - (b) Tribal People Framework.
- (vii) Detailed guidance to users for specific facility usages to be elaborated.
- (viii) The following generic content needs to be further revised:
 - (a) List of regulations are outdated and not comprehensive. Environmental regulations and their applicability are presented in generalized manner. The applicable environmental regulations should be discussed, clearly specifying:

- Scope of the Applicable Act/Regulation
 - Relevance of the Act/Regulation
 - Category/ Sub-project/ Activity wise State specific key requirements under the Applicable Regulations.
- (b) All possible impacts of even temporary projects should be assessed and detailed out. Risk Management section should mention the risks, including, health & safety risks, etc. from local and regional perspectives.
- (c) Environmental and Social Standards of the World Bank's Environment and Social Framework (ESF) are merely listed out in the document. The ESF and the relevance/applicability of the Environmental and Social Standards should be discussed in the context of the project along with the justification.
- (ix) Issues and relevant regulations pertaining to Heritage buildings need to be detailed out.
- (x) While environmental and social issues are more prominent w.r.t. component B of NSRMP, activities under component A & C will do have considerable environmental and social issues. Thus environmental and social issues should be discussed w.r.t. all the three components of NSRMP, i.e., Component-A, B & C.
- (xi) Documentation of Stakeholder consultations will be part of ESMP.
- (xii) The Consultant will approach the World Bank's Sr. Environmental Specialist for Structure and specific guidance note for ESMF.
- (xiii) Consultant's Environmental and Social Specialists must visit all nine (9) project States/UTs for field survey.
- (xiv) All discussions pertaining to environmental & social aspects of NSRMP will be tripartite involving NDMA, World Bank and Consultant's representatives.
- (xv) There will be separate discussion on model DPR.
